# **SECTION 4) First-aid Measures**

#### Inhalation:

Remove source of exposure or move person to fresh air and keep comfortable for breathing. Get medical advice/attention if exposed, feel unwell (headache, nausea, drowsiness etc.) or are concerned.

#### **Eve Contact:**

If irritation occurs, cautiously rinse eyes with lukewarm, gently flowing water for 15-20 minutes, while holding the eyelids open. If eye irritation persists: Get medical advice/attention.

#### **Skin Contact:**

Rinse/wash with lukewarm, gently flowing water and mild soap for 5 minutes or until product is removed. If skin irritation occurs or you feel unwell: Get medical advice/attention.

#### Ingestion:

Rinse mouth. If you feel unwell or if concerned: Get medical advice/attention.

If more than several mouthfuls have been swallowed, give two glasses of water (16 Oz.). Get medical attention.

#### Notes:

High velocity injection of grease under the skin may result in serious injury. If left untreated, the affected area is subject to infection, disfigurement, lack of blood circulation and may require amputation. When dispensed by high-pressure equipment, this material can easily penetrate the skin and leave a bloodless puncture wound. Material injected into a finger can be deposited into the palm of the hand and in rare occasions up to the elbow. Within 24 to 48 hours the patient may experience swelling, discoloration, and throbbing pain in the affected area. Immediate treatment by a surgical specialist is recommended.

# **SECTION 5) Fire-fighting Measures**

#### Suitable Extinguishing Media:

Dry chemical, foam, carbon dioxide, water spray or fog is recommended. Water spray is recommended to cool or protect exposed materials or structures. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam. Water or foam may cause frothing. If leak or spill has not ignited, use water spray to cool the containers and to provide protection for personnel attempting to stop the leak.

# Fire-fighting Procedures:

# **SECTION 6) Accidental Release Measures**

#### **Emergency Procedure:**

Immediately turn off or isolate any source of ignition. Keep unnecessary people away; isolate hazard area and deny entry. Do not touch or walk through spilled material. Clean up immediately. Contain spill. Wipe up or add suitable absorbent, non-combustible, inert material such as sand. sawdust. etc. to spill area and shovel into appropiate container for disposal. #### **Personal Precautions:**

Avoid breathing vapor. Avoid contact with skin,eye or clothing. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing.

Will not produce vapors unless heated to temperatures of ~300 °F.

#### **Environmental Precautions:**

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers.

# **SECTION 7) Handling and Storage**

#### General:

Wash hands after use.

# Eye protection:

# Skin protection:

Use of gloves approved to relevant standards made from the following materials may provide suitable chemical protection: PVC, neoprene or nitrile rubber gloves. Suitability and durability of a glove is dependent on usage, e.g. frequency and duration of contact, chemical resistance of glove material, glove thickness, dexterity. Always seek advice from glove suppliers. Contaminated gloves should be replaced. Use of an apron and over- boots of chemically impervious materials such as neoprene or nitrile rubber is recommended to avoid skin sensitization. The type of protective equipment must be selected according to the concentration and amount of the dangerous substance at the specific workplace.

#### Respiratory protection:

If engineering controls do not maintain airborne concentrations to a level which is adequate to protect worker, a respiratory protection program that meets or is equivalent to OSHA 29 CFR 1910.134 and ANSI Z88.2 should be followed. 


