Although precipitated silica was temporarily deposited in animals' lungs, most of the deposited material was cleared soon after the dust exposure ended. The results of all studies performed by, or known to, PPG indicated a very low order of pulmonary activity for synthetic precipitated silicas. PPG recommends that persons with


