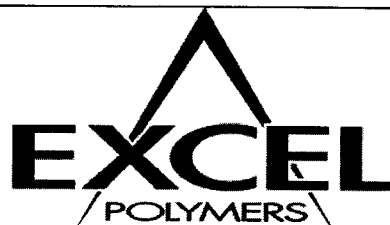

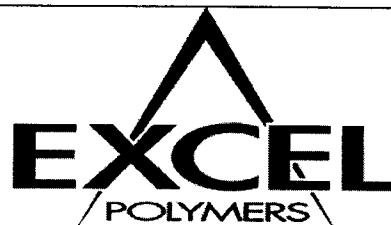
**3. HAZARDS IDENTIFICATION****EMERGENCY OVERVIEW**
